The Plymouth County Board of Supervisors met in adjourned session on November 13th to canvass the city elections held on November 6th for Akron, Merrill, Oyens, Struble and Westfield. All members were present.

Results are as follows:

City of Akron

For the office of City Council there were nine hundred thirty-three (933) votes cast as follows: John E Lucken received two hundred twenty-eight (228) votes, Milton Schneider received one hundred seventy (170) votes, Eugene E Stabe received two hundred thirty-five (235) votes, Ronald D Wilmot received two hundred eighty-eight (288) votes, scattering received twelve (12) votes. We therefore declare Eugene E Stabe and Ronald D Wilmot duly elected to the office of City Council for the term of four (4) years.

For the office of City Council, 2 year unexpired term, there were four hundred fifty-one (451) votes cast as follows: Robert L Frerichs received two hundred seventy-eight (278) votes, scattering received one hundred seventy-three (173) votes. We therefore declare Robert L Frerichs duly elected to the office of City Council, 2 year unexpired term, for the term of two (2) years.

For the office of Care Center Trustee there were seven hundred sixty-two (762) votes cast as follows: Joy Dirks received four hundred fifteen (415) votes, Curtis Lewison received three hundred forty-six (346) votes, scattering received one (1) vote. We therefore declare Joy Dirks and Curtis Lewison duly elected to the office of Care Center Trustees for the term of four (4) years.

City of Merrill

For the office of Mayor there were one hundred sixty-eight (168) votes cast as follows: Richard R Husman received one hundred fifty-three (153) votes, scattering received fifteen (15) votes. We therefore declare Richard R Husman duly elected to the office of Mayor for the term of two (2) years.

For the office of City Council there were three hundred fifty-seven (357) votes cast as follows: Bradley R Brooks received ninety-one (91) votes, Margaret Marienau received one hundred sixty (160) votes, Bruce Rolling received one hundred five (105) votes, scattering received one (1) vote. We therefore declare Margaret Marienau and Bruce Rolling duly elected to the office of City Council for the term of four (4) years.

City of Oyens

For the office of Mayor there were twenty-two (22) votes cast as follows: Marcel Konz received twenty-one (21) votes, scattering received one (1) vote. We therefore declare Marcel Konz duly elected to the office of Mayor for the term of two (2) years.

For the office of City Council there were sixty-two (62) votes cast as follows: Robert L Gengler received twenty (20) votes, Brian Juhl received twenty (20) votes, Steven Swalve received twenty (20) votes, scattering received two (2) votes. We therefore declare Robert L Gengler, Brian Juhl and Steven Swalve duly elected to the office of City Council for the term of four (4) years.

City of Struble

For the office of Mayor there were twenty-five (25) votes cast as follows: Joseph N Vollmecke received twenty-four (24) votes, scattering received one (1) vote. We therefore declare Joseph N Vollmecke duly elected to the office of Mayor for the term of two (2) years.

For the office of City Council there were one hundred thirty (130) votes cast as follows: Charles H Hahn received thirteen (13) votes, Robert D Hughes received twenty-one (21) votes, Barry Jurgenson received eighteen (18) votes, Cliff Lambert received nine (9) votes, Karen Paulsen received ten (10) votes, Delbert L Sanow received sixteen (16) votes, Kenneth C Urban received twenty (20) votes, Michael Vander Molen received twenty-three (23) votes. We therefore

declare Robert D Hughes, Barry Jurgenson, Delbert L Sanow, Kenneth C Urban and Michael Vander Molen duly elected to the office of City Council for the term of two (2) years.

City of Westfield

For the office of Mayor there were fifty-seven (57) votes cast as follows: Michael Bohlke received fourteen (14) votes, William A Hummel received forty-three (43) votes. We therefore declare William A Hummel duly elected to the office of Mayor for the term of two (2) years.

For the office of City Council there were one hundred fifty-one (151) votes cast as follows: Gerald L Bohr received twenty-four (24) votes, Jo Ann Eden received thirty-four (34) votes, Richard Lindberg received thirty-eight (38) votes, Nancy McFarland received twenty (20) votes, Lyle McInnis received thirty-five (35) votes. We therefore declare Jo Ann Eden, Richard Lindberg and Lyle McInnis duly elected to the office of City Council for the term of four (4) years.
