The Plymouth County Board of Supervisors met in adjourned session on February 13, 2002 with all members present. All votes following are aye unless otherwise indicated.

Minutes of the February 6th and 12th minutes were read and approved.

Motion by Philips, seconded by Spies, to approve the zoning boards recommendation of a change from ag conservation to ag rural residential for Armond Brown on 3.8 acres in section 28 of Johnson Township. Motion carried.

Motion by Sitzmann, seconded by Philips, to approve the zoning boards recommendation of a change from ag conservation to commercial for William LaBahn on 5 acres in section 35 of Liberty Township subject to conditional use permit. Motion carried.

Motion by Spies, seconded by Kestner, to approve the preliminary plat of Lohry subdivision in section 22 of Perry Township subject to conservation. Motion carried.

Motion by Sitzmann, seconded by Kestner, to approve the zoning boards denial of a change from ag conservation to ag rural residential for Kenneth Krieg on 3.29 acres in section 14 of Elkhorn Township. Motion carried.

Motion by Spies, seconded by Philips, to approve the preliminary and final platting of Jackson Addition in section 31 of Hungerford Township. Motion carried.

Motion by Philips, seconded by Kestner, to approve the zoning boards denial of a change from ag conservation to ag rural residential on Lot 1 of Jackson Addition in section 31 of Hungerford Township for William Jackson. Motion carried.

Motion by Kestner, seconded by Philips, to approve the zoning boards denial of the preliminary plat and final plat of Ohl's Hillside Acres in section 27 of Hungerford Township. Motion carried.

Motion by Philips, seconded by Kestner, to accept the bid of Mike Anthony for (7) Delta faucets replacement at the county home for \$605.50. Motion carried.

Motion by Kestner, seconded by Philips, to replace (8) mirrors at \$72.50 plus shipping for each mirror at the county home. Motion carried.

Motion by Sitzmann, seconded by Kestner, to hire Jeff Gengler a mechanic for secondary road beginning March 4th at \$14.38 an hour. Motion carried.

Motion by Philips, seconded by Kestner, to adopt *Resolution #021302 Concerning an embargo on Marble Avenue from 160th Street South to the concrete paving from February 18 to May 24th*

Motion by Spies, seconded by Philips, to adopt *Resolution #021402, #021502, #021602 and #021702 To add to our farm-to-market system 3.99 miles of L-22, 3.219 miles of C-80, 3.058 miles of 320th Street and West Loop Road, and 3.99 miles of L-22.*
