Linda Dobson, Co. Treasurer, gave the Board an update on Driver's Licensing. We contract for a CDL examiner with Sioux County. A Plymouth Co. examiner will get the CDL training necessary to do the examining for our county.

Bob Kurth questioned the Building Setback Line for Golfview Estates. The original platting shows 60' BSL from the center of the road.
