Minutes of the December 13, 2005 meeting were approved.

Hearing was opened at 10:00 a.m. on Plymouth County/LeMars Highway 75 Bypass Urban Renewal Area (2005 Amendment). The hearing was closed at 10:02 a.m.

Motion by Sitzmann, seconded by Schneider, to approve Resolution 122005 "Urban Renewal Plan Amendment for the Plymouth County/LeMars Highway 75 Bypass Urban Renewal Area".
