The Plymouth County Board of Supervisors met in the Boardroom on June 13, 2006 at 9:30 a.m. All members were present. All votes following are aye unless otherwise indicated.

Canvass of the June 6<sup>th</sup> Primary Election was done with the following results:

For the office of Board of Supervisor District 1-Democrat, there were two hundred thirty-four (234) votes cast as follows: Kirk Klohs received two hundred thirty-four (234) votes.

For the office of Board of Supervisor District 1-Republican, there were nine hundred thirteen (913) votes cast as follows: C. Gordon Greene received five hundred sixty-two (562) votes; James F. Kestner received three hundred fifty-one (351) votes. We therefore declare C. Gordon Greene as the winner.

For the office of Board of Supervisor District 3-Democrat, there were two hundred seventy two (272) votes cast as follows: Paul J. Sitzmann received two hundred seventy-two (272) votes.

For the office of Board of Supervisor District 3-Republican, there were seven hundred fifty-six (756) votes cast as follows: Don Kass received seven hundred fifty-five (755) votes; scattering received one (1) vote.

For the office of Board of Supervisor District 4-Republican, there were seven hundred fifty-nine (759) votes cast as follows: Craig A. Anderson received seven hundred forty-four (744) votes; scattering received fifteen (15) votes.

For the office of County Treasurer-Republican, there were eight hundred forty-three (843) votes cast as follows: Linda A. Dobson received eight hundred forty-three (843) votes.

For the office of County Recorder-Republican, there were eight hundred eight (808) votes cast as follows: Jolynn Goodchild received eight hundred eight (808) votes.

For the office of County Attorney-Republican, there were seven hundred seventy-five (775) votes cast as follows: Darin J. Raymond received seven hundred seventy-two (772) votes; scattering received three (3) votes.

Motion by Anderson, seconded by Henrich, to approve the canvass of the June 6<sup>th</sup> Primary Election. Motion Carried.

Motion by Anderson, seconded by Schneider, to approve an application for construction on county road right-of-way for Cherokee Rural Water in Sec 5/8 of Stanton Twp. Motion Carried.

Motion by Schneider, seconded by Henrich, to approve right-of-way contracts on Project LB-341108 in Sec 11 Fredonia Twp with Dave Vander Hamm for \$1,034.00 and Gary Juhl, etal for \$1,424.00. Motion Carried.

The Board of Supervisors met with the L.O.S.T. Advisory Board to discuss the committee’s suggestions and procedural changes. No board action was taken.
