The Plymouth County Board of Supervisors met in the Boardroom on June 6, 2006 at 9:30 a.m. All members were present. All votes following are aye unless otherwise indicated.

The agenda for the June 6, 2006 meeting was approved.

Minutes of the May 30, 2006 meeting were approved.

Motion by Greene, seconded by Anderson, to approve the re-zoning of 57.48 acres from Transitional Agriculture to Industrial located in pt NW ¼ NW ¼ (20 acres) and pt SW ¼ NW ¼ (37.48 acres) of Sec 2 Plymouth Twp for construction of a 50 million gallon ethanol plant, with the Board of Adjustments approval of the blue print before a conditional use plan is issued. Motion Carried.

Michelle Bostinelos, SIMPCO's Transportation Planning Director, presented the 2030 Long Range Trans. Plan to the Board as part of the process to secure Federal transportation funds for the Metropolitan Planning Org.

The 2005-2006 Budget Amendment hearing was opened at 10:20 a.m. for public comments. Hearing was closed at 10:29 a.m. Motion by Henrich, seconded by Schneider, to approve the Budget Amendment for 05-06. Motion Carried.

John Becker of Plymouth Energy L.L.C. discussed the proposal for the 50 million gallon corn ethanol plant in rural Merrill and the progress on the project thus far.

Motion by Henrich, seconded by Anderson, to approve a permit for High Tech Electric to place phone cables for Qwest Communications in Sec 4 & 9 of Plymouth Twp. Motion Carried.

Motion by Schneider, seconded by Anderson, to approve the R.O.W. contract for project LC-033410. Motion Carried.

The Board adjourned at 11:19 a.m.

The Plymouth County Drainage District Board opened at 11:20 a.m.

Motion by Anderson, seconded by Henrich, to approve the special tax assessment for all parcels in the City of Westfield. Motion Carried.
