The Plymouth County Board of Supervisors met in the Boardroom on March 7, 2006 at 9:15 a.m. Present were Sitzmann, Greene, Spies and Henrich. Absent was Schneider. All votes following are aye unless otherwise indicated.

Canvass of the February 28<sup>th</sup> Special Election was done with the following results:

For the office of Board of Supervisor District 4-, there were one thousand two hundred fifty votes cast as follows: Craig Anderson received seven hundred three votes; Ken Spies received five hundred nineteen votes; scattering received twenty-eight votes. We therefore declare Craig Anderson as the winner.  
Motion by Greene, seconded by Henrich to approve the canvass of the election. Motion Carried.

Motion by Henrich, seconded by Sitzmann, to accept the bid of Anthony Construction to re-shingle the EMS building for \$12,452 to be paid from the county building line item.

Motion by Greene, seconded by Henrich, to adopt Resolution #030706 granting a time extension for Lang's Addition in Sec 23 93-46.
