The agenda for the September 26, 2006 meeting was approved.

Minutes of the September 19, 2006 meeting were approved.

Motion by Greene, seconded by Anderson, to sponsor the Organic Growers Conference with \$300.00 from the Rural Services fund. Greene-aye; Anderson-aye; Henrich-aye; Schneider-nay; Sitzmann-nay Motion Carried.

Motion by Anderson, seconded by Schneider, to approve an application from Southern Sioux Rural Water for construction on county road right-of-way in Sec. 18 Washington Twp/Sec. 24 Johnson Twp, Sec. 2/3 Johnson Twp, Sec. 24 Johnson Twp, Sec. 2 Westfield Twp, Sec. 1/2 Westfield Twp, Sec. 11/14 Westfield Twp, Sec. 23 Westfield Twp, Sec 23/26 Westfield Twp, and Sec 26/25 Westfield Twp. Motion Carried.

Motion by Henrich, seconded by Greene, to approve the final plans for LC-172785 and LC-132780. Motion Carried.

Motion by Anderson, seconded by Schneider, to approve a permit for construction on county road ROW for N.W. Iowa Power Coop in Sec. 25/26 Washington Twp. Motion Carried.

Motion by Greene, to approve paving of 100' of roadway to access the Starwood Estates at a cost of \$25,000 to \$30,000 on a 1/3 – 2/3 split. Motion died for lack of a second.

Motion by Anderson, seconded by Greene, to approve paving of approximately 300' of roadway to access the Starwood Estates in Sec. 28 90-47 at a split of 33% county, 67% owner with an approximate cost of \$45,000.

Motion by Anderson, seconded by Schneider, to amend previous motion to say with approval of all zoning requirements. Amendment Carried.
