The agenda for the February 6, 2007 meeting was approved.

Minutes of the January 30, 2007 meeting were approved.

Motion by Schneider, seconded by Kass, to reduce the Compensation Board's recommendation by 10% for the budget year 2007-2008. Schneider-aye; Kass-aye; Anderson-aye; Greene-nay; Henrich-aye Motion Carried.

Motion by Kass, seconded by Schneider, to set raises for Plymouth County non-union personnel at 4.5% for Fiscal year 2007-2008 including but not limited to: County Engineer, Assistant Engineer, Engineer Superintendent, Engineer's Administrative Assistant, Sanitarian, Zoning personnel, Economic Development Director, CPC Coordinator, Veterans Affairs Director, Sheriff's Administrative Assistant, Driver's License personnel, Courthouse Maintenance personnel, IT Director and Victim Witness Coordinator.
