The Plymouth County Board of Supervisors met in the Boardroom on September 18, 2007 at 9:30 a.m. Present were Vice Chairman Schneider, members Anderson, Kass and Greene. Chairman Henrich was absent at the start of the meeting and arrived later. All votes following are aye unless otherwise indicated.

The agenda for the September 18, 2007 meeting was approved.

Motion by Greene, seconded by Schneider, to approve an application for construction on county owned ROW for MidAmerican Energy in Sec 6 Preston Twp. Motion Carried.

Motion by Anderson, seconded by Greene, to approve an application for construction on county owned ROW for Southern Sioux Rural Water in Sec 20 Johnson Twp. Motion Carried.

Motion by Anderson, seconded by Kass, to approve a contract with Graves Construction Co-Project BRS-CO75(113)—60-75 in Sec 2/3 Plymouth Twp. for \$297,270.53 with the intent to include this in the Urban Renewal area being established. Motion Carried.
