Motion by Anderson, seconded by Kass, to approve the agenda for December 14, 2010. Motion Carried.

Larry Petersen presented the Compensation Board's recommendation of a 4% increase for all elected officials for FY 2011-12.

Rob Bixenman, Plymouth County's ICAP agent, was present to review the County's general liability coverage for the 24 County townships. There is bonding coverage and general liability for township officials. The County may consider adding the 3 township halls to the Counties policy as well.

Terry Reuter, representative from the Plymouth County Fair, was present to discuss the Plymouth County Fair and is seeking \$10,000 of funds for FY 2011-12.
