Motion by Kass, seconded by Guenther, to approve the January 15, 2013 agenda. Motion Carried.

Motion by Guenther, seconded by Kass, to approve the minutes of the January 8, 2013 meeting. Motion Carried.

Motion by Kass, seconded by Guenther, to approve Resolution #011513-1, an agreement between Plymouth County and the City of Le Mars assigning all interest in Crescent Ridge to the City for \$297,500.00. Motion Carried.
