The Plymouth County Board of Supervisors met in the Boardroom on June 21, 2016 at 9:30 a.m. All members were present. All votes following are aye unless otherwise indicated. Board Chairman Henrich called the meeting to order and the Pledge of Allegiance was recited.

Motion by Anderson, seconded by Kass, to approve the June 21, 2016 agenda. Motion Carried.

Motion by Loutsch, seconded by Meis, to approve the minutes of the June 14, 2016 meeting. Motion Carried.

Motion by Anderson, seconded by Loutsch, to approve wages paid on 6-17-16 and claims that were paid on 6-21-16. Motion Carried.

Motion by Loutsch, seconded by Meis, to the contract with Williams & Co. for FY 2015-16 audit. Motion Carried.

Motion by Meis, seconded by Kass, to approve the revised Plymouth County Policy/Handbook effective July 1, 2016. Motion Carried.

Motion by Anderson, seconded by Loutsch, to approve Resolution #062116 to standardize medical payments as the Federal Medicare rates, for the Plymouth County Sheriff office for the care and custody of all prisoners with in Plymouth County. Motion Carried.

Motion by Kass, seconded by Anderson, to approve a minor subdivision of Ahlers Home and Ag, in Section 22 of Meadow Township. Motion Carried.

Motion by Anderson, seconded by Meis, to approve a minor subdivision of Jauer Addition, in Section 15 of Hungerford Township. Motion Carried.

Motion by Anderson, seconded by Meis, to approve a permit for Consolidated Communication in Section 30 and 9 of Johnson Township. Motion Carried.

Motion by Loutsch, seconded by Meis, to approve a permit to United Private Networks in Section 32, 33, 34 of Preston Township on 160th St. Motion Carried.

The Board of Supervisors discussed the Lake Ave/C 38 pavement issues and drainage issue and would only consider covering 1/3 of the cost of the project with the land/business owner paying the other 2/3 along with providing the land for the right of way on their property. Tom Rohe, County Engineer, is discussing the project again with the landowner.
