Motion by Anderson, seconded by Kass, to approve the March 8, 2016 agenda. Motion Carried.

Motion by Anderson, seconded by Loutsch, to approve the minutes of the February 23, 2016 meeting. The meeting on March 1, 2016 was cancelled due to lack of agenda items. Motion Carried.

Motion by Anderson, seconded by Kass, to approve payroll paid on 2-26-16 and on 2-29-16 and the claims paid on 3-1-2016. Motion Carried.
