Minutes of the December 5<sup>th</sup> meeting were read and approved.

Motion by Sitzmann, seconded by Spies, to approve the zoning boards recommendation of a change from ag conservation to rural residential for Dennis Wilken in Section 1 of Westfield Township subject to conditional use. Motion carried.

Motion by Spies, seconded by Vander Hamm, to approve the zoning boards recommendation of a change from ag conservation to rural residential for Maxine Sager as execution of the Ross Sager estate in Section 19 of Lincoln Township. Motion carried.

Motion by Vander Hamm, seconded by Sitzmann, to approve an application for construction on county road right of way for Lyle Krienert in Section 22 and Section 23 of Grant Township. Motion carried.

Motion by Kestner, seconded by Spies, to approve an application for construction on county road right of way for Todd Popken in Section 27 and Section 34 of Preston Township. Motion carried.
