The Plymouth County Board of Supervisors met in adjourned session on September 14th to canvass the School Board election held on September 11th. Present were Vice Chairman Vander Hamm, members Kestner, Sitzmann and Spies.

The following results were found:

Akron-Westfield

For the office Director District 3 there were one hundred two (102) votes cast as follows: Jenell S. Lanning received one hundred one (101) votes, scattering received one (1) vote. We therefore declare Jenell S. Lanning duly elected to the office of School Board Member-District 3 for a term of 3 years.

For the office of Director District 4 there were one hundred fourteen (114) votes cast as follows: James Black received one hundred thirteen (113) votes, scattering received one (1) vote. We therefore declare James Black duly elected to the office of School Board Member-District 4 for the term of 3 years.

For the office of Director District 6 there were one hundred seventeen (117) votes cast as follows: Amy Mace received one hundred seventeen (117) votes. We therefore declare Amy Mace duly elected to the office of School Board Member-District 6 (unexpired) for the term of 1 year.

For the office of Western Iowa Tech Community College Director District 1 there were seventy-four (74) votes cast as follows: John Ribando received seventy-four (74) votes. We therefore declare John Ribando duly elected to the office of WITCC District 1 for the term of 3 years.

Upon the public measure "Shall the number of directors in the Akron-Westfield Community School District be reduced from seven (7) to five (5) to be elected from four (4) Director Districts and one (1) At-Large, effective at the 2002 regular school election?" there were one hundred twenty-five (125) votes cast as follows: **FOR** the question there were fifty-nine (59) votes cast. **AGAINST** the question there were sixty-six (66) votes cast. We therefore declare the public measure "see above" to be adopted.

Hinton Community

For the office of Director At-Large there were forty-two (42) votes cast as follows: Barry Dittmer received forty (40) votes, scattering received two (2) votes. We therefore declare Barry Dittmer duly elected to the office of Director At-Large for the term of 3 years.

For the office of Western Iowa Tech Community College Director District 1 there were thirty-seven (37) votes cast as follows: John Ribando received thirty-seven (37) votes. We therefore declare John Ribando duly elected to the office of WITCC District 1 for the term of 3 years.

Kingsley-Pierson

For the office of Director District 3 there were ninety-three (93) votes cast as follows: Gregg Roepke received ninety-three (93) votes. We therefore declare Gregg Roepke duly elected to the office of School Board Member-District 3 for the term of 3 years.

For the office of Director District 5 there were ninety-five (95) votes cast as follows: Tim Sudbeck received ninety-four (94) votes, scattering received one (1) vote. We therefore declare Tim Sudbeck duly elected to the office of School Board Member-District 5 for the term of 3 years.

Le Mars Community School

For the office of Director District 2 there were eighty-two (82) votes cast as follows: Cris Collins received eighty-two (82) votes. We therefore declare Cris A Collins duly elected to the office of School Board Member-District 2 for the term of 3 years.

For the office of Director At-Large there were eighty-three (83) votes cast as follows: Patrick N Murphy received seventy-nine (79) votes, Mark E Stelzer received eighty-three (83) votes. We therefore declare Patrick N Murphy and Mark E Stelzer duly elected to the office of Director At-Large for the term of 3 years.

For the office of Western Iowa Tech Community College Director District 1 there were seventy-one (71) votes cast as follows: John Ribando received seventy-one (71) votes. We therefore declare John Ribando duly elected to the office of WITCC District 1 for the term of 3 years.

Remsen-Union

For the office of Director District 3 there were thirty-one (31) votes cast as follows: Mark Kunkel received thirty-one (31) votes, Connie Sudtelgte received twenty-six (26) votes. We therefore declare Mark Kunkel duly elected to the office of School Board Member-District 3 for the term of 3 years.

For the office of Director District 4 there were sixty-nine (69) votes cast as follows: Darrel J Schroeder received sixty-nine (69) votes. We therefore declare Darrel J Schroeder duly elected to the office of School Board Member-District 4 for the term of 3 years.

Western Iowa Tech Community College

For the office of Director District 1 there were one hundred eighty-two (182) votes cast as follows: John Ribando received one hundred eighty-two (182) votes. We therefore declare John Ribando duly elected to the office of WITCC District 1 for the term of 3 years.
