The Plymouth County Board of Supervisors met on September 16, 2005 at 8:30 a.m. to canvass the School Board Election held on September 13<sup>th</sup>, 2005. Present were Chairman Greene, members Schneider and Henrich. Absent were members Spies and Sitzmann.

Motion by Henrich, seconded by Schneider, to approve the canvass of the School Board Election as follows:

#### AKRON-WESTFIELD

For the office of Director District 5 there were 117 votes cast: Janet Willer received 102 votes; Tambrey Groves received 12 votes; scattering three 3 votes. We declare Janet Willer elected to the office of Director District 5 for the term of 3 years.

For the office of Director District 6 there were 120 votes cast: Kirk Banks received 108 votes; scattering 12 votes. We declare Kirk Banks elected to the office of Director District 6 for the term of 3 years.

For the office of Director At Large there were 135 votes cast: Roger Oetken received 127 votes; scattering 8 votes. We declare Roger Oetken elected to the office of Director At Large for the term of 3 years.

#### HINTON COMMUNITY

For the office Director At Large there were 388 votes cast: Bradley D. Held received 42 votes; Robert D. Held received 79 votes; Kenny J. Hoefling received 100 votes; Julie Vander Plas received 55 votes; Ed Vondrak received 112 votes. We declare Ed Vondrak and Kenny J. Hoefling elected to the office of Director At Large for the term of 3 years.

#### KINGSLEY-PIERSON

For the office of Director District 2 there were 66 votes cast: Bill Riordan received 65 votes; scattering 1. We declare Bill Riordan elected to the office of Director District 2 for the term of 3 years.

For the office of Director District 4 there were 62 votes cast: Cindy Inman received 62 votes. We declare Cindy Inman elected to the office of Director District 4 for the term of 3 years.

#### LEMARS COMMUNITY

For the office of Director District 3 there were 103 votes cast: Marjorie Franke received 102 votes; scattering 1 vote. We declare Marjorie Franke elected to the office of Director District 3 for the term of 3 years.

For the office of Director District 5 there were 107 votes cast: Dan Smith received 107 votes. We declare Dan Smith elected to the office of Director District 5 for the term of 3 years.

#### REMSSEN-UNION

For the office of Director District 2 there were 14 votes cast: Arlie Pick received 14 votes. We declare Arlie Pick elected to the office of Director District 2 for the term of 3 years.

WESTERN IOWA TECH COMMUNITY COLLEGE

For the office of Western Iowa Tech Director, District VII, there were 81 votes cast: Curt Grigg received 79 votes; scattering 2 votes. We declare Curt Grigg elected to the office of WIT Director, District VII for the term of 3 years.
